## Order Rules at the OE-Plads

#### RUN

Access to the site must take place by driveway from Gudenåvej (west of the "rye station"). At driveway (about 50 meters from the county road) there is a boom across the road. This boom can be unlocked, but for the sake of undesirable driving in the forest area, the boom must be locked when the camp site is not used. Driving from the campsite through the forest may only take place in an emergency.

#### THE FOREST

The forest that lies up to the camp site belongs to Vissinggård, and traffic in the forest is covered by the new nature protection law.

Please note that during the period from 1 October to 1 January, the forest may be closed due to hunting, usually Saturdays and Sundays. Remember at all orienteering races and major tournaments (with more than 30 participants), you must obtain permission from the landlord no later than 20 days before.

#### **PARKING**

Reference is made to parking at the notice board. If additional parking is required, please refer to the parking lot to the right of the boom at the entrance. Parking of motor vehicles on the grassland areas of the camp site is not allowed and driving on the grassland may only take place by loading and unloading of equipment. Caravans can only be brought along with the landlord in agreement.

#### SOIL

The camp site's soil is very sandy, which means that there are never water problems - even with very heavy rain, the water is absorbed immediately.

## WATER

Water and prime quality from Vissinggård's private waterworks are performed. Should problems arise with the water supply, the landlord may be contacted - or contact supervisor.

### EL

There is electricity in the square, which can be used for a fee of DKK 3.5 per person. kWh.

#### BONFIRE

If a fire is to be lit, one of the established fire places must be used or dug.

Under normal circumstances, fires must be switched on taking into account the general rules for fire distances. Fire places must be dug as needed, but care must be taken to irrigate the turf for the nature of the soil. When loosening the fire pit, it must be excavated and drained before the turf trays are put in place. The grass pits must be laid approx. 4 cm higher than the adjacent area, as

he excavated soil will sink. Camp bonfire must be held at the well-established campfire at the south.

#### BURN

There must be no firewood in the forest. There are firewood throughout the tribes that the tenant himself can cut and split in the depot at the camp site's northern end. But be environmentally conscious and considerate when using firewood - REMEMBER A GOOD LEARNING BOAT DO NOT NEED TO BE A LARGE CAMP! On departure, excess firewood should be left in the repository - and not in the rafting stand. Chipping should not be left on the camp site, but must be collected and burned.

#### **NEIGHBORS**

It was the former owners of "Vissinggård" who in 1967 donated the O.E. site to the Danish Scout Corps, and since then, changing administrators of the camp site have always had the goal of maintaining a good neighborly relationship on all sides. In order for this relationship to be preserved, it goes without saying that all our tenants always display proper scout-like behavior and traffic in the area and take into account staying away from the neighbors' residential area.

It is expected that great consideration will be given to both nature and the neighbors and therefore RO between 11.00 and 16.00. 22.00 and 6.30

#### Rafter

The rafting stand is always well stocked with rafters, but on the other hand, we expect users to help us keep track of the rafters and place them properly in place. Remember that the root end (the thick end) must face the middle. Unusable rafters that are either broken, tender or otherwise damaged are placed in the fire depot.

#### TOILETS

At the edge of the forest at the southern end of the square there are 5 dry toilets. Southwest of the Shelter is buried a collecting tank in which the toilet buckets must be emptied as needed and on departure. It is our intention that the tenants always arrive at cleaned toilets, and on departure, the toilets must be emptied and buckets and rooms cleaned.

In case of inadequate cleaning, a fee of 500 Kr is imposed. Toilet paper and toilet fluid are brought by the bearings.

#### WASHING AND PERSONAL HYGIENE

This must under no circumstances take place in or near the lake, as Neden Skovsø is a very clean lake with no access or exit, and it is therefore very sensitive to pollution. Likewise, any form of dishwashing and food preparation as well as toothbrushing at the water drainage points are provided. The dishes must be placed on the camp site, where the sandy soil will act as a filter. Personal toilette refers to the toilet building with the shower rooms, where the waste water can be blown out towards the back, where there are drains towards the excavation (formerly the country cottage)

#### **BATHING**

There is fine sand bottom but all bathing takes place on the manager's responsibility and should only be done under supervision - possibly. in framed bathing area. On the opposite side of the lake is a public bathing area with toilets. PROHIBITION: In the southern end of the lake, the owners of Vissinggård have a private bathing area with bridge and tilt, as well as bath houses and boats. This

area is strictly private and the campsite residents have absolutely no access to use these facilities. This prohibition must be observed.

#### SAILING

At the campsite there are a number of plastic drums for the construction of rafts. Furthermore, there are a larger number of life jackets in several sizes. Sailing with rafts may only take place in the northern half of the lake, D.V.S. north of the campsite's southern end. Except for any. salvage vessel (rubber boat or similar) in connection with sailing with rafts, all other sailing in the lake is prohibited.

## **FISHING**

Fishing in the lake is not allowed.

## TRASH

There are containers at the entrance to the square The waste must be deposited in these.
